This "Emergency Assistance for Secure Elections Act" is incredibly important for Pennsylvania. It is perhaps our last and best chance to replace at least some of the Direct Record Electronic voting machines that so many states are finding unreliable and insecure, and to protect our 2008 election with a true voter-verified paper ballot. HR 5036 will:

- Provide federal funds to enable any state or county that wishes to replace paperless Direct Record Electronic (DRE) machines with a voter-marked paper ballot system using scanners or hand counts.
- Provide federal funds to any county or state that wants them for emergency paper ballots to be used if their current Direct Record Electronic machines break down on election day.
- Provide federal funds to any county or state that wants them to conduct manual audits or hand counts of the 2008 election.
- \$633 million in funding is authorized.

The HR 5036 program is entirely optional. Whether or not a state or county opts in is entirely up to the state or county. Opting in entitles the state or county to reimbursement.

HR 5036 already has the support of many voting rights organizations, as well as public officials such as the National Association of Counties.
